2. Position the speakers on a stable surface to prevent accidental falls that could result in damage or injury.
3. Avoid prolonged exposure of the product to direct sunlight, as elevated temperatures can potentially compromise its longevity, impact the battery life, and distort certain plastic components.
4. Protect the speaker from extreme cold conditions, which may harm the internal circuitry.
5. Note that rechargeable batteries have a finite number of charge cycles, and their longevity varies based on usage and settings.
6. Prevent liquids from entering the device.
7. Before cleaning the speakers with a dry cloth, ensure the power switch is in the off position, and disconnect the power cord from the outlet.
8. Refrain from subjecting the product to throwing or stamping, as this could result in damage to the internal circuitry.
9. Avoid attempting to disassemble the device; such actions should be exclusively performed by a qualified professional.
10. Refrain from using concentrated chemicals or detergents when cleaning the product.
11. Utilize power supplies rated at 5V/2A~20V/1A only. Connecting power sources with higher voltages might lead to severe damage.
12. Disposing of or placing the lithium battery near fire or intense heat must be avoided to prevent any risk of explosion.
